#### NATO'S PAST, PRESENT, AND FUTURE: A VIEW FROM EUROPE

His Excellency Radoslaw Sikorski, Minister of Foreign Affairs, Poland



In this first program of the fall 2008 Chicago and the World Forum series, "Europe and the United States: Navigating the Future," Polish Foreign Minister Radoslaw Sikorski addresses the future of the world's strongest military alliance. As NATO looks toward its 60th anniversary in 2009, the organization is evolving to address myriad new issues confronting its members. With new missions in Afghanistan and Kosovo redefining NATO's area of responsibility,

it is essential that NATO modernize while remaining true to its core mission and maintaining vital military operations around the globe. But as national priorities shift and the clarity of the Cold War world is gone, new and unique questions arise: how can NATO reconcile the varying transatlantic approaches to pressing global issues? What is NATO's role in shaping the strategic dialogue between Europe and the United States? How will the expansion of NATO affect relations with countries like Russia, and will expansion fundamentally change the nature of the alliance? Foreign Minister Radoslaw Sikorski will address these and other key questions in exploring the European-U.S. relationship and the future of their military alliance.

Sikorski has served as Poland's minister of foreign affairs since 2007. Previously, he served as minister of defense and as Poland's deputy minister for foreign affairs. #### THE PATH TO A NEW MIDDLE EAST

Marwan Muasher, former Foreign Minister of Jordan  
Kenneth M. Pollack, Director of Research, Saban Center for  
Middle East Policy, Brookings Institution

Two expert Middle East observers will discuss the political, economic, and social dynamics of a region central to U.S. policy and of crucial importance in this election year. For Ambassador Marwan Muasher, Arab moderates hold great promise in the region, if they can regain ground recently lost to religious extremists. Calling for reformed governments that invest in their citizens, practice tolerance for diverse political views, and actively seek peace, he also questions the effectiveness of U.S. policy. Kenneth Pollack argues that, despite frustrations about the Iraq war and other regional engagements, the United States must continue to make the Middle East a foreign-policy priority and make a sustained and patient effort to help its people overcome the problems facing their governments and societies.

In conversation with each other, Muasher and Pollack will explore and debate the realities on the ground, the various paths forward, and ways for the United States and the people of the region to shape the future together. **A CONVERSATION WITH THE COUNSELOR**

Ted Sorensen, former Special Counsel and Adviser to President John F. Kennedy  
Interviewed by Bruce Dold, Editorial Page Editor,  
*Chicago Tribune*



Ted Sorensen spent ten years as the closest adviser and speechwriter to senator and then president John F. Kennedy. In 1965, he wrote a glowing reminiscence, *Kennedy*, but now – forty-five years after Kennedy's assassination and fourteen years after the death of Jacqueline Kennedy Onassis – Sorensen opens up with a more candid look at the late president. His 2008 book, *Counselor*, offers dramatic and personal insights into the Kennedy White House, the Cuban missile crisis, the civil rights movement, the decision to go to the moon, and the founding of the Peace Corps – all in the one thousand days of “Camelot.” In this presidential election year, the history of these times is more relevant than ever, especially as seen through the eyes of an extraordinary figure in American politics.

After serving in the Kennedy administration, Sorensen became a widely published author on the presidency and foreign affairs, as well as a leading international lawyer, practicing for over thirty-six years as a senior partner, and now of counsel, at the law firm of Paul, Weiss, Rifkind, Wharton & Garrison LLP. He has continued to be active in the Democratic Party and is on numerous boards. His memoirs, *Counselor: A Life at the Edge of History*, will be available for purchase at the program. World-renowned pollster John Zogby maintains that the “great American dream” is in transition, with new demographic groups such as the “First Globals” contributing to a redefinition of the American character. This new, globally oriented generation is the first to bring a consistently global perspective to everything from foreign policy and environmental issues to consumer choices on everything from coffee to music. It is also dramatically influencing public attitudes toward foreign policy, driven by a world view shaped by greater appreciation for diversity and tolerance, America's approach to Iraq and the Middle East generally, and other pressing international issues. Zogby will reflect on how this transition will affect the November elections, and what this shift means for America's place in the world. Zogby International is known for its expertise in calling elections. What does Zogby foresee about this one?

Zogby is president and chief executive officer of the polling firm Zogby International, which polls for Reuters, MSNBC, CNBC, the *New York Post*, Fox News, C-Span, and numerous other newspapers and news services. Zogby International has partnered with Reuters and C-Span for Election 2008. Zogby regularly appears on all three nightly network news programs plus the *Today Show* and *Good Morning America*, among others. **SCIENCE IN THE NEW MILLENNIUM**

Dr. Alan Leshner, Chief Executive Officer,  
The American Association for the Advancement of Science

Science and technology have become integral parts of the American political agenda. The president and Congress alike deal daily with issues like global climate change, surging demands for affordable energy, biomedical research – including the use of embryonic stem cells – and a continuing need to sustain national competitiveness in science, engineering, and medicine. The proportion of national issues that involve science and technology has increased dramatically in recent years and is likely to continue to do so throughout the 21st century. Addressing the role of science and technology in driving America's economy and international competitiveness is vital in the age of globalization and never more relevant than in this presidential election year.

Alan Leshner is chief executive officer of the American Association for the Advancement of Science (AAAS) and executive publisher of its journal, *Science*. Previously, Dr. Leshner had been director of the National Institute on Drug Abuse at the National Institutes of Health (NIH), and deputy director and acting director of the National Institute of Mental Health. Before that, he held a variety of senior positions at the National Science Foundation. He is an elected member of the Institute of Medicine of the National Academies of Science and vice chair of its governing council, and a fellow of AAAS, the National Academy of Public Administration, and the American Academy of Arts and Sciences. Dr. Leshner was appointed by the president to the National Science Board and is a member of the advisory committee to the director of NIH. He received an A.B. in psychology from Franklin and Marshall College and M.S. and Ph.D. in physiological psychology from Rutgers University. Dr. Leshner also has been awarded five honorary doctor of science degrees.
